DIRECTIONS FOR COMPLETING REGISTRATION FORMS

1. Complete the form "USTA League Team Information Sheet."
 - A. Write the name of your local league in space next to Local League.
(Do not write the name of your team or your facility.)
 - B. Write your team's level in the space next to NTRP Level.
 - C. Write your team number in the space next to Team #.
 - D. Place a checkmark next to the appropriate gender.
 - E. Place a checkmark next to the appropriate division, Adult or Senior.
 - F. In the Players column, write the name of the captain on the first line. If original captain is not the acting captain for the State Championships, list the acting captain's name. **Enter all players by last name first. All players other than captain should be entered alphabetically.**
2. Include a copy of your roster from TennisLink.
3. Entry Fee is **\$25 for each player**. This check should be made out to your local league.
4. Deposit Fee is **\$250.00 per team**. This check should be made out to USTA Georgia. Teams who fail to complete all scheduled matches will forfeit both their entry fee and deposit, and will be subject to sanctions during the next league year. At the conclusion of scheduled matches, all deposit checks will be destroyed.

Teams that withdraw twenty-two (22) days in advance of the start of the tournament will be reimbursed their security deposit and entry fee. Teams that withdraw within twenty-one (21) days of the start of the tournament and the posting of the draw will not be reimbursed their entry fee. Teams that withdraw once the draw is posted will forfeit their security deposit, entry fee and a grievance may be filed by the referee to the appropriate committee.

2010 USTA Georgia League Tennis State Championships Cancellation Policy

Teams that withdraw twenty-two (22) days in advance of the start of the tournament will be reimbursed their security deposit and entry fee. Teams that withdraw within twenty-one (21) days of the start of the tournament and the posting of the draw will not be reimbursed their entry fee. Teams that withdraw once the draw is posted will forfeit their security deposit, entry fee and a grievance may be filed by the referee to the appropriate committee.

Should inclement weather or other circumstances prevent the completion of a State Championship; the Tournament Committee will determine whether the matches played at the point of cancellation will be used to determine the round robin group winners and a champion and finalist in each level.

If the Tournament Committee determines that there was a lack of “equal opportunity” for all teams in the level due to the schedule of play, the Tournament Committee will place all teams in a drawing to determine the champion and finalist in each level. (For instance, in a five team round robin, one team may be in first place at the time of cancellation with two matches played, while other teams in the round robin have fewer matches played. This example would not provide “equal opportunity” for all teams in the round robin and would not be used to determine the round robin group winner).

If any team in a round robin flight is mathematically out of contention at the time of cancellation, they will be excluded from the drawing.

Most Often Asked Questions about the State Championships

If you have a question about the 2010 USTA Georgia League Tennis State Championships; refer to this sheet as a handy reference.

1. Our team won both the summer/fall and winter/spring seasons, but a couple of our players were different. Can we take all our players?

No. You must choose which season you are representing - the fall or the spring. Only those players on that roster, and who are otherwise qualified, may play. You cannot combine rosters.

2. How many matches does a player have to have played locally to be eligible to participate at the USTA Georgia Adult State Championship?

A player must have played two matches during the same local league season, including local playoffs, in which his/her team qualified for the state championship. One default received by the player during local competition shall count for advancing. A retired match shall count toward advancing for all players involved.

3. How soon can we get our match schedule?

The tentative schedule will be posted on the USTA Georgia Web Page (www.adult.ustageorgia.com) or the Central Savannah River Area Tennis Association Web Page (www.csratenis.com) a week before tournament starts. No schedules will be mailed to captains. At registration, captains will receive a final schedule that will replace the tentative one.

4. Why do I have to attend the captains' meeting?

At the captains' meeting we go over all the specific rules that apply for the tournament. All announcements concerning schedule changes are made at this time. The captains' meeting is the only way we can ensure you are informed of changes or special situations you need to know about in order to make your tournament as smooth as possible. The captain may send a representative to this meeting.

5. Our team only has four players available. Will we have to forfeit all our matches?

You must have a minimum of eight players who can play all five positions, but if the Tournament Committee approves this prior to the tournament your team will be allowed to play with only 4 players for the entire tournament.

If this is not pre-approved, you are allowed to default two of the five lines, but you can not do it every match. Showing up to a match with less than 4 players will result in the team being defaulted from the tournament and the team will be subject to the same penalties as if they had withdrawn.

*** Players must play at the level their rating was at the time of their local league play!**

Directions to Host Hotel: Augusta Marriott (2 10th Street, Augusta, GA 30901)
Registration and Captain's Meeting

*If you are traveling on I-20, exit at Exit 200 River Watch Park Way. Turn left onto River Watch Park Way and follow into downtown Augusta. At 15th Street continue straight across and stay on Jones St. until you reach 10th Street. Turn left onto 10th Street and as you cross Reynolds Street you will see the parking entrance on your right.

*If you are coming from from Southeast Georgia (traveling on US 25 or US 1). Follow either road until you merge with Gordon High Way by bearing to the right (you should be headed East) onto Gordon High Way. Follow Gordon High Way to Walton Way (Red Lobster on your right and Wendy's on your left) and turn left. Immediately turn right onto 5th Street and follow to Reynolds Street. Turn left onto Reynolds Street and follow to 10th Street. Turn right and the Augusta Marriott will be on your right.

Directions to Newman Tennis Center (3103 Wrightsboro Road, Augusta, GA 30909) – **Hard Courts**

*If you are traveling on I-20, turn South at Exit 196-A onto Bobby Jones Parkway (I-520) and take it to Exit 2, Wrightsboro Road. Turn left on to Wrightsboro Rd. and travel approximately 2 miles to a traffic light at our entrance. Newman Tennis Center is on the left.

*If you are coming from from Southeast Georgia (traveling on US 25 or US 1) enter Bobby Jones Parkway (North/West) and go toward I-20 (Atlanta/Columbia SC), exit at Exit 2 (Wrightsboro Road), turn Right on to Wrightsboro Road and travel approximately 2 miles to the traffic light in front of the Newman Tennis Center Entrance.

From Newman Tennis Center

To Petersburg Racquet Club (PRC) (421 The Pass, Martinez, GA, 30907) (706-860-9288) – **Hard Courts**
Westlake Country Club (WLCC) (3556 Westlake Dr., Martinez, GA) (706-863-4018) – **Clay Courts**

*Turn right out of the parking lot onto Wrightsboro Road and follow to I-520 (Bobby Jones Parkway). Turn right onto I-520 West and follow to Washington Rd (you will pass under I-20 and go approx. 2 miles). Turn right on Washington Rd (O'Reilly's Auto Parts on the right) and follow for about 1 mile to Baston Rd. (2nd traffic light) and turn left. As you turn left onto Baston Rd you will see Jim Hudson Lexus on your right. Follow Baston Rd (you will pass Augusta Christian on your left) and turn left onto Fury's Ferry Road. **To PRC:** As you turn left on Fury's Ferry Rd., stay in the left lane and prepare to turn left on to The Pass (Wachovia Bank on the right at the corner). Follow The Pass 7/10 of a mile and turn left on to Cedar Rock Drive (large rock on the corner). Petersburg Racquet Club is on the right, just past the homes. **To WLCC:** Follow Fury's Ferry past the Wachovia Bank to the next traffic light and then turn right into Westlake Country Club. Stop at the guard gate and get a pass. As you leave the guard gate, turn right on to Westlake Dr. and follow for about ¾ of a mile. Westlake Tennis Center will be on your left.

To Fleming Tennis Center (FTC) (1850 Chester Ave., Augusta, GA 30906) (706-796-5046) – **Hard Courts**

*Turn right out of parking lot onto Wrightsboro Road and follow to I-520. Turn left onto I-520 and follow to exit 9. Turn left onto HWY. 56 (Old Savannah Road.) and follow to Chester Ave. (you will cross the railroad tracks and it will be the first through street on your left). Turn left onto Chester Ave. and the courts will be 200 yards on your left.

* **Directions to all sites, including practice facilities will be handed out at the captain's registration***

From Newman Tennis Center

To Diamond Lakes Park (DLP) (103 Diamond Lakes Way, Hephzibah, GA 30815) (706-772-2418) – **Hard Courts**

*Turn Right out of the parking lot onto Wrightsboro Road and follow to I-520, go under the overpass and enter I-520 going East/South. Follow I-520 East/South to exit 7 and turn Right onto Windsor Springs Road. Follow Windsor Springs Road for about 4.7 miles and turn right into Diamond Lakes Park. The Tennis Center will be about 4/10 of a mile, on your Left.

To Riverview Park (RP) (100 Riverview Park Dr., N. Augusta, SC 29841) – **Hard Courts**

*Turn Left on Wrightsboro Road, follow to Monte Sano (4th light) and turn left. Follow to Walton Way and turn right. Follow Walton Way to 13 Street (approx. 4 miles) and turn left on to 13 Street. Follow 13 Street over the bridge, crossing the Savannah River into South Carolina. The road changes to Georgia Ave. in South Carolina. Follow to the first traffic light and turn left on to West Buena Vista Ave. Follow until it dead ends at Georgetown Dr. and turn left. Follow Georgetown Dr. into Riverview Park. The tennis courts are up the hill on the right.

To The Club at Rae's Creek (RC) (3206 West Wimbledon Dr., Augusta, GA 30909) (706-738-4122) – **Hard Courts**

Turn Right out of the parking lot onto Wrightsboro Road and follow to the second traffic light. Turn right onto Jackson Rd. (Subway on the right). Follow to the next traffic light and just before the light, turn right onto Walton Way. Go 1/10 of a mile to West Lake Forest Dr. and turn right. Follow and turn right at Kerry St. (3rd street). Go to the end and turn left on Kamel. At the bottom of the hill turn right on to Wimbledon Dr. and the club is straight ahead.

To Patriot's Park (PP) (5445 Columbia Rd., Grovetown, GA 30813) (706-868-3485) – **Hard Courts**

*Turn right out of the parking lot onto Wrightsboro Road and follow to I-520 (Bobby Jones Parkway). Turn right onto I-520 West and follow to I-20 West (toward Atlanta). Follow I-20 West until Exit 190 and turn right on to Lewiston Rd. Follow Lewiston Rd. to Columbia Rd. and turn left. Go about 2 miles on Columbia Rd. and you will turn right into Patriot's Park. The tennis courts will be on your immediate left.

*** Directions to all sites, including practice facilities will be handed out at the captain's registration***

From Augusta Marriott (Host Hotel) (2 10th Street, Augusta, GA 30901)

To Newman Tennis Center (3103 Wrightsboro Road, Augusta, GA 30909) – **Hard Courts**

*From the front of the hotel turn right onto Reynolds St. and follow to 13th Street. Turn left onto 13th St. and follow to Walton Way. You will cross Walton Way and the road name changes to R A Dent. Follow R A Dent and as you approach the 15th St. overpass the name changes again to Wrightsboro Road. Follow Wrightsboro Road approx. 3.3 miles and Newman Tennis Center will be on your right (just after you pass Daniel Field Airport).

To Petersburg Racquet Club (PRC) (421 The Pass, Martinez, GA, 30907) (706-860-9288) – **Hard Courts**

*Turn Right onto Reynolds St. and follow to 15th St. Continue through the intersection and the road becomes River Watch Park Way. Follow to Fury's Ferry Road (you will go under I-20 and Fury's Ferry will be approx. 2 miles ahead). Turn Right on Fury's Ferry Road and follow 1.4 miles. Turn left onto The Pass (there is a traffic light with a Wachovia Bank on the right and a BI-LO on the left). Stay on The Pass for 0.7 miles and turn left onto Cedar Rock Drive (there is a big rock at the corner). The courts will be on your right after you pass the homes.

To Fleming Tennis Center (FTC) (1850 Chester Ave., Augusta, GA 30906) (706-796-5046) – **Hard Courts**

*From the Hotel turn left on Reynolds St. and go 0.4 miles and turn right onto 7th St. Go approx. 0.6 to Walton Way and turn left. Follow approx. 0.3 mi. to Gordon Highway (Highway 25 South) and turn right. Follow Gordon Highway approx. 3.4 mi. and take the overpass to Peach Orchard Road (High Way 25 South). Follow Peach Orchard Road and turn left at the first traffic light onto Highway 56 - Mike Padgett Highway. From the Traffic light travel 1.0 miles and turn right onto Chester Ave. Travel approx. 0.2 miles and the Tennis Courts will be on the left.

To Patriot's Park (PP) (5445 Columbia Rd., Grovetown, GA 30813) (706-868-3485) – **Hard Courts**

Turn Right onto Reynolds St. and follow to 15th St. Cross 15th St., go straight at corner and the road becomes River Watch Park Way and follow I-20. Enter I-20 going toward Atlanta (West) and follow to exit 190. Exit at 190 and turn right onto Lewiston Rd. and follow to Columbia Rd. Turn left onto Columbia Rd. and the park is about 2 miles on your right and the courts are immediately on your left.

To Diamond Lakes Park (DLP) (103 Diamond Lakes Way, Hephzibah, GA 30815) (706-772-2418) – **Hard Courts**

From the Hotel turn left on Reynolds St. and go 0.4 miles and turn right onto 7th St. Go approx. 0.6 to Walton Way and turn left. Follow approx. 0.3 mi. to Gordon Highway (Highway 25 South) and turn right. Follow Gordon Highway approx. 3.4 mi. and take the overpass to Peach Orchard Road (High Way 25 South). Follow Peach Orchard Road and turn Right onto Windsor Springs Road and follow for 4.7 miles, turn right into Diamond Lakes Park. The Tennis Center is .4 miles on your Left.

From Augusta Marriott (Host Hotel) (2 10th Street, Augusta, GA 30901)

To Riverview Park (RP) (100 Riverview Park Dr., N. Augusta, SC 29841) – **Hard Courts**

*From the Hotel turn right on to Reynolds St. and follow to 13th St. Turn right and go across the bridge into SC. The road changes to Georgia Ave. At the first traffic light, turn left onto W. Buena Vista Ave. and follow to the dead end at Georgetown Dr. Turn left and follow into the park. The courts are on the hill on your right.

To The Club at Rae's Creek (RC) (3206 West Wimbledon Dr., Augusta, GA 30909) (706-738-4122) – **Hard Courts**

*Turn Right onto Reynolds St. and follow to 15th St. Turn left onto 15th St. and follow to Walton Way (CVS Pharmacy will be on your right). Turn right onto Walton Way and follow approx. 4.8 miles to West Lake Forest Drive. Turn left onto West Lake Forest Drive and follow it to Kerry (the 3rd right turn). Turn right onto Kerry and at the T intersection turn left onto Kamel. At the bottom of the hill turn right and the club is straight ahead. (Do not park along the road, please use designated parking)

To Westlake Country Club (WLCC) (3556 Westlake Dr., Martinez, GA) (706-863-4018) – **Clay Courts**

*Turn Right onto Reynolds St. and follow to 15th St. Continue through the intersection and the road becomes River Watch Park Way. Follow to Fury's Ferry Road (you will go under I-20 and Fury's Ferry will be approx. 2 miles ahead). Turn Right on Fury's Ferry Road and follow 1.7 miles. The entrance to West Lake will be on your right at the traffic light. Turn right on Inverness Way, stop at the guard gate and get a pass, then turn right on to West Lake Drive and follow approx. 1.2 miles until you see the Country Club entrance on your left.

Augusta Practice Facility Directions

From Newman Tennis Center

To Warren Road Community Center

*Turn Right on to Wrightsboro Road and follow to I-520 and turn right. Go to I-20 and turn right (toward Columbia, SC) exit at exit 199 and turn left onto Washington Rd. Follow Washington Rd. to Warren Rd. (just past Piccadilly Cafeteria). Turn left onto Warren Rd. The courts are 1/2 mile down Warren Rd. on the left.

To Lakeside High School

*Turn right out of the parking lot onto Wrightsboro Road and follow to I-520. Turn right onto I-520 and follow to I-20. Turn East toward Columbia, SC., exit at exit 199 (Washington Rd.). Turn left on Washington Road and follow to Fury's Ferry Road. (Dairy Queen on the right). Turn right onto Fury's Ferry Road and follow (approx. 5 miles) to Evans-To-Lock-Rd. Turn left and follow to Blue Ridge Rd. turn left and then left again at the entrance to Lake Side High School and Middle School. The courts are behind the High School.

To Evans High School

*Turn right out of the parking lot onto Wrightsboro Road and follow to I-520. Turn right onto I-520 and follow to I-20. Turn West toward Atlanta and follow to exit 194. Turn right onto Belair Road. Follow Belair Road and cross Columbia Road, follow to Cox Road and turn left. Evans High School will be on your left. Go past the school and turn into parking lot after buildings. Courts are around the back side of the school.

To Lakeside High School

*Turn left on Wrightsboro Road and follow to Monte Sano (4th light) and turn left onto Monte Sano. Follow to Walton Way, turn right. Follow Walton Way to Megs St. (just before the Partridge Inn) and turn right. The court is .25 mile on the left at Hickman Park.

To East Riverside High School

*Turn right out of the parking lot onto Wrightsboro Road and follow to I-520. Turn right onto I-520 and follow to I-20. Turn East toward Columbia, SC., exit at exit 199 (Washington Rd.). Turn left on Washington Road and follow to Fury's Ferry Road. (Dairy Queen on the right). Turn right onto Fury's Ferry Road and follow until you pass Riverside Middle School. Take the next road on the left (Hardy McManus). Go .5 miles to the entrance to Dolphin Way and turn right (Riverside Elementary School) Courts are on your left behind the school.
